A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
WATSONVILLE DELEGATING AUTHORITY TO THE CITY
MANAGER TO EXECUTE CERTIFICATES OF ACCEPTANCE
OF DEEDS CONVEYING DESIGNATED PROPERTY
INTERESTS TO THE CITY

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. That the City Manager of the City of Watsonville
is hereby granted authority and directed to execute forms of
"CERTIFICATE OF ACCEPTANCE", as attached hereto as Exhibit "A"
on behalf of the City Council of the City of Watsonville in
order to accept for purposes of recordation those deeds for
transfer and conveyance of real property interests to the
City of Watsonville, as provided in Section 37354 of the State
Government Code, designated as follows:

- a. Deeds to dedicate property and rights of way to implement an approved subdivision map, land division, or other approved development.
- b. Deeds to dedicate property and rights of way to implement approved utility extensions.

2. That the City Manager is hereby directed to include
in the monthly report to the City Council an itemization and
identification of those deeds accepted for recordation by
the City Manager during the last thirty (30) day report period.
