Fees effective July 1, 2016 to June 30, 2019

2- Permanent Tie Down Rates (monthly)

Taxi-In Spots

Aircraft over 12,500 pounds \$650.00

3 - Temporary Tie-Down Fees

Aircraft over 12,500 pounds per Night \$100.00

Aircraft over 12,500 pounds per Week \$400.00

6 - Un-Airworthy Aircraft Fee (annual) \$500.00

7 – Special Events/Slot Reservation Fee\$100.00

8 – Aircraft Handling Fee \$100.00

10- Fuel Island Convenience Card Fee (annual) \$150.00

11 - Commercial Operator Permit Fee (per event) \$150.00

Note: Effective Rates will be adjusted annually by the rate of the April to April change in the Consumer Price Index (CPI). Effective Fees will be adjusted July 1, 2019.

The hearing is established by virtue of California Government Code Section 66018.
